

Section 4. The official returns shall be delivered to the City Secretary, who is hereby directed to enter in the election register the tabulations of the votes cast for each candidate to preserve such as required by law.

Section 5. That notice of said election was duly and properly given as required by law, that said election was duly held, and that returns thereof were made by the proper officials of said elections and in all things according to law.

Section 6. *Severability.* That if any section, subsection, sentence, clause, or phrase of this order or the application of the same to a particular person, or to a particular set of circumstances, should for any reason be held invalid, such invalidity shall in no way affect the remaining portions of this Order and to such end, the various portions and provisions of this Order are declared to be severable.

SYNOPSIS

Update on status of agreement between the City and developer

BACKGROUND

The City of Missouri City's thoroughfare plan anticipates a connection from Cravens Road to Beltway 8. The development of the road would have a positive impact on traffic on Gesner by providing an more direct route for truck traffic to access the beltway.

Fort Bend County included the project in their last mobility bond package. They have agreed to fund nearly \$1,000,000 to the cost of the project. The total anticipated cost of the project is anticipated to be approximately \$3,000,000. As the location of the connection is in both Fort Bend County and Harris County, the funds from Fort Bend County can only be used on the portion of the road in Fort Bend County.

At present, the City does not have the funds necessary for its portion of the project. Without the match, the city cannot access the Fort Bend County mobility bond funds. If the city match for mobility bond funds are not forthcoming in the near term, the County portion of the funds may be reallocated to other projects.

To ensure the connection is constructed and county mobility bond funds are not lost the City has been working with the owner of the property where the road would built. The owner has agreed to provide the city's match and construct the road. The owner requests that in consideration for building the road within an agreed timeline and to agreed standards the property owner has requested the City enter into a Chapter 380 agreement and be reimbursed by the County mobility bond funds for the portion of the road within Fort Bend County.

Recognizing the economic benefit to the city and the ability to complete a project on the City's thoroughfare plan the City Council authorized the City Manager to negotiate and execute a Chapter 380 agreement with the owner/developer. The City Manager, his staff and the City Attorney have worked with the owner/developer to finalize the appropriate Chapter 380 agreement. The agreement accomplishes the goals of

1. Ensuring the connector road is developed in an agreed timeline and to agreed standards
2. Leverages the Fort Bend County Mobility Bond Funds without the expenditure of city funds
3. Sets the source of payment and limits the amount of payment under the agreement as the funds received from Fort Bend County for the segment of the road in Fort Bend County

The agreement has been finalized and is being executed as this agenda item is submitted.
