MAY 17, 2021 MEETING MINUTES**

The Board of Directors of the Missouri City Recreation and Leisure Local Government Corporation held a meeting on **Monday, May 17, 2021**, at **5:15 p.m.** at Missouri City Community Center, 1522 Texas Parkway, Missouri City, Texas, to consider the following:

**1. ROLL CALL**

Chair Elackatt called the meeting to order at 5:19 p.m.

Those also present: Director Clouser, Sterling, Boney and Emery; Treasurer Portis, Secretary Iyamu, Golf Course Manager Stittleburg, Interim Chief Administrative Officer Atkinson, Assistant City Manager Martel, City Secretary Jackson and Director of Communications Walker. **2. Consider approving the minutes of the meeting of May 3, 2021.**

Director Boney moved to approve the minutes of the May 3, 2021 meeting. Director Emery seconded.

**3. Discuss the midyear budget review.**

Golf Course Manager Stittleburg presented the midyear budget review.

Director Boney asked if Cares Act Funding may be used for the golf course. Interim Chief Administrative Officer Atkinson stated that Assistant City Manager Martel was reviewing the American Recovery Act to see if it may be used for the golf course but noted the golf course was not eligible for the Cares Act Funding.

Vice Chair Maroulis inquired about the First Tee program. Stittleburg stated it was booked and it was geared towards youth development.

Chair Elackatt asked if the contract pertaining to maintenance was a year to year contract. Stittleburg explained it had always been negotiated as a year to year contract. Elackatt inquired if people were allowed to bring their own food. Stittleburg stated that the course were the only ones providing foods, and noted diverse cultural foods would be present for 2022 budget.

Director Clouser stated she would like to see more advertising and a site that event planners could go to. Director Emery inquired about the strategic plan, a 10% increase in revenue, and opportunities in the maintenance contract. He also asked what it would take to increase the revenue. Stittleburg stated increasing prices and more people purchasing items would increase revenue. Directors thanked Stittleburg for his hard work.

Without objection, Chair Elackatt adjourned the meeting at 5:45 p.m.
