All applicants must furnish:

- ❑ Completed Registration Statement Form
(Certificate and identification card(s) good for 180 days)
Pages 1 & 2 are about the company & applicant.
Page 3 is for all other individuals—copy as needed.
- ❑ 1 – 2"x2" color or black and white identification photo for applicant and each individual
(Can be smaller & can be color copy from TXDL)
- ❑ Required fee(s)
(\$100 fee for company registration certificate, applicant & up to 4 additional individuals
\$25 per individual thereafter
\$5 per replacement identification card)

Food vendors must also furnish:

- ❑ Copy of valid Missouri City Health Permit
(If food vendors, Missouri City Code attached)

Corporations must also furnish:

If incorporated in Texas

- ❑ Certified copy of charter or articles of incorporation
- ❑ Certificate of good standing

If incorporated in a state other than Texas

- ❑ Certified copy of certificate of authority to do business in the State of Texas
- ❑ Certificate of good standing

Registration Certificate & ID Cards can be picked up:

- ❑ In 1 to 3 days
- ❑ Upon the applicant's and/or each individual's presentation of driver's license (or other identification)
