The City of Missouri City hereby gives notice that the City will hold a Joint Election with Fort Bend County and Harris County on November 3, 2020 from 7:00 a.m. to 7:00 p.m. for voting in:

- A general election to elect a Mayor, a Councilmember-At-Large, Position 1, and a Councilmember-At-Large, Position 2, for two-year terms from November 2020 to November 2022; and,
- A special election to consider a proposition providing for or against the adoption of the fire fighters' and police officers' civil service law.
