The City Council of the City of Missouri City, Texas, met in special session on **Sunday, February 21, 2021**, at the City Hall, Council Chamber, 2nd Floor, 1522 Texas Parkway, Missouri City, Texas, 77489, at **1:00 p.m.** to consider the following:
