SYNOPSIS

This item supplements a March 5, 2021 agreement for temporary solid waste services necessitated by Tropical Storm Nicholas that occurred in on or about September 14, 2021, by providing debris collection services to all residents within the jurisdictional limits of the City of Missouri City.

STRATEGIC PLAN 2019 GOALS ADDRESSED

• Create a great place to live

BACKGROUND

On or about March 5, 2021, the City of Missouri City ("City") entered into an agreement with WCA Waste Corporation ("WCA"), the City's solid waste service provider, for additional temporary solid waste services, including construction and demolition waste collection services which may be required due to damage and destruction from floods, tornadoes, windstorms, ice storms, and other local disasters; and solid waste, debris collection and disposal services which may be required due to such disasters.

The City has supplemented the aforementioned contract with WCA, as provided in the agreement, to provide debris collection services citywide as a result of Tropical Storm Nicholas. Under the new scope of work, such service is to be provided to all residents in the City of Missouri City jurisdictional limits. The services for debris collection will be carried out on Saturday, September 25, 2021, and October 2, 2021. Residents will not need to call in for service, and may place the debris out for collection on the designated days.

1.	DISASTER EVENT:	Tropical Storm Nicholas
2.	DATE OF REQUEST:	September 14, 2021
3.	DATES OF SERVICE:	September 25, 2021 and October 2, 2021
4.	DESCRIPTION OF SPECIFIC SERVICES REQUESTED:	Services described in Exhibit A of the Agreement. Specifically, WCA will operate up to six (6) rear load waste collection vehicles manned by up to 3 crew members each.
5.	GEOGRAPHIC LOCATION:	A. Services shall be provided to the entire territorial jurisdiction of the City of Missouri City, Texas
